ZİDEK Directive on Publicity and Presentation

ARTICLE 1 Basis, Purpose and Scope

This directive has been prepared to define how the presentations made on behalf of ZİDEK, presentations publicizing ZİDEK and presentations on the accreditation processes and criteria of ZİDEK shall be conducted by ZİDEK members, ZAK members or ZİDEK office.

ARTICLE 2 Definitions

In this directive:

- (a) **ZİDEK** shall stand for the Association for Evaluation and Accreditation of Agricultural Engineering Educational Programs,
- (b) **ZİDEK Members** shall stand for the members of ZİDEK Association,
- (c) **Executive Board** shall stand for ZİDEK Executive Board,
- (d) **ZAK** shall stand for the Agricultural Engineering Programs Accreditation Board,
- (e) **ZİDEK Office**, shall stand for ZİDEK Secretary General or other employees of ZİDEK.

ARTICLE 3 ZİDEK Publicity and Presentations

ZİDEK Executive Board shall be informed before every ZİDEK publicizations and ZİDEK presentations to be conducted by members of Executive Board, ZAK members, ZİDEK members or the ZİDEK Office. Executive Board may be informed by the chair of the board, ZİDEK Office or ZAK.

Most current information on ZİDEK and ZİDEK standard formats shall be used for presentations made on behalf of ZİDEK. ZİDEK standard formats can be obtained from the ZİDEK Office

Digital copies of presentations made with the approval of ZİDEK Executive Board shall be handed over to the ZİDEK Office after the presentation

ARTICLE 4 Amendments to the Directive

Proposals for amendments to this directive may be submitted by the Executive Board members, ZAK members, ZİDEK members or ZİDEK Office. The proposals are put on the agenda of, and shall be resolved during, the first meeting of the Executive Board.

ARTICLE 5 Enforcement

This directive enters into force as of the date of approval by the Executive Board.
